The necessary supports are provided so that they may achieve personal goals and maintain their independent residence in the community. MHA staff provides an array of individually tailored services including clinical assessment, counseling, case management, transportation, and assistance with activities necessary to maintain independent residence such as budgeting and cooking. There were 2095 people served during 2015

Children's Programs Provides intensive in-home counseling and case management services to families referred by the Family Crisis Intervention Program, DYFS, and other community referral sources. (See Attached Schedule O)

Community Social Services Provides professional consultation to families and loved ones of adults with mental illness. One to one support and education is provided to the families with the goal of helping them to understand serious mental illness, to respond in a manner most helpful to the consumer, and to support their loved one in a way that maintains their own sense of well-being. In addition, MHAMC provides assistance with navigating community resources and organizing residents of communities in need. There were 172 clients served
